Conservation Areas

Osmotherley and Thimbleby both include designated "conservation areas" encompassing the historic cores of the villages. Conservation areas are defined in legislation as areas "of special architectural and historic interest, the character or appearance of which it is desirable to preserve or enhance". There are over 8000 conservation areas nationwide covering a very diverse range of historic sites from twentieth-century housing estates such as New Earswick at York, to the Settle-Carlisle Railway line in the Dales. The National Park contains 42 conservation areas, predominantly focused on the centres of historic towns and villages, but also including a planned Victorian parkland at Guisborough.

In Osmotherley, the conservation area boundary runs to the south behind the primary school, crossing South End to include Back Lane to the east, continuing behind the rear boundaries of houses on North End up to Ruebury Lane and back down to include Grant Close and then follow the line of the pathway along the long plots behind West End to Cuddy Lane and back across the fields to the primary school. The area therefore includes most of the village's historic buildings but excludes more modern developments on the peripheries. It was designated in 1977.

In Thimbleby, the conservation area encompasses the whole of the village. Because the National Park boundary runs along the main road, responsibility for planning control is split between the National Park Authority (to the south) and Hambleton District Council. It was designated in 1986, and as a small, linear rural village with generously spaced houses it has a very different character to Osmotherley's more bustling, almost country town character with tightly packed terraced housing. The main statutory effect of designation is that the local planning authority has a duty to ensure that development that takes place within the area preserves or enhances its architectural and historic character. Obviously to some extent this judgement will always be subjective, so it is important for residents and the local planning authority to understand what the elements are that contribute to the area's distinctive character. Initiatives such as the production of a village design statement, and in the future the production of a conservation area appraisal, are important contributors towards a shared understanding of character, and should help applicants, consultees and planners to evaluate, comment on and make informed decisions on development proposals.

One problem with trying to ensure that development preserves character has always been that most small changes such as alterations to windows, doors, roofing and walls have been classed as "permitted development" and so have not been controlled by the planning authority. As a result, much of what makes the area architecturally and historically distinctive - slate roofs, Yorkshire sliding sash windows etc. - can be subject to unsympathetic alteration, with small changes cumulatively eroding the justifications for conservation area status.

The introduction of article 4 directions in Osmotherley and Thimbleby in 2006 means that these sorts of external changes now require a free application for planning permission so that the Authority has control over the design and materials when traditional features such as doors and windows are being replaced. As a way of encouraging the reinstatement of such features where they have been lost in the past, the National Park has been able to offer conservation area enhancement grants towards the work. This has only been possible as a result of the article 4 direction because of the requirement to protect the investment of public funds in the future. So far, four properties in Osmotherley have received grants towards the reinstatement of traditional windows and doors, and the Parish Council has received grant for the repair of areas of cobbling. Residents of the National Park who are considering replacing modern materials such as plastic windows or concrete pantiles with timber or clay, or modern designs with traditional, are welcome to contact me for further information on the grants available or with any queries about the Article 4 controls.
